Policies and Procedures

Payment:

Payment: Cash, Check, and VISA/MASTERCARD (**Make checks out to Swimkids.**)

Fees: Fees will apply for declined credit cards, bounced checks, etc.

Registration Fee: An annual registration fee of \$30 per private student is charged each year. This fee covers all types of studio AND swimming classes.

Refunds: **We do not offer refunds.** We take great care to provide our customers with the class they need, at the time that they prefer. Once a student has reserved a lesson or a spot in a class, that spot is no longer marketable and considered sold.

Make-Ups and Absences:

Cancellations:

*To cancel a lesson: Call 801.944.8811. Our phones are on 24 hours a day. Leave a message clearly stating your child's name and the day and time of the lesson you are cancelling. **We do not accept any other form of communication to cancel a lesson.**

**A No Show / No Cancel student is not eligible for a make-up lesson*

Make Ups

* Cost is \$5.00 per 15- min private make up. (free make-ups are given for monthly pay students who give a 30-day notice that they will miss a lesson)

*Please contact the office as soon as possible if you are going to miss a lesson. Makeup lessons are subject to availability.

Dress Code:

For Studio classes, dress your child in any type of exercise clothing for the first day of class. At the first class attendance, talk to your teacher about proper attire for your child's future classes.

Conditions of Enrollment:

All students need to arrive on time dressed in proper attire. Students who are more than 10 minutes late to class may be asked to sit and watch class to prevent injury as they have missed warm-up. Students who are not dressed in proper attire may also be asked to sit and watch class.

When entering the studio after a swim lesson, student must be fully dry and in dry clothes. No swimsuits, wet or dry, will be allowed in the studio.

Students need to leave all personal belongings outside of the studio to prevent loss or distraction. Swimkids is not responsible for any loss of personal items.

To change or add a class, a class change form must be filled out and submitted to the office. It is the responsibility of the parent or guardian to keep up to date on the student's schedule changes, events, and any notices through email, voicemail, newsletters, and SwimKids website.

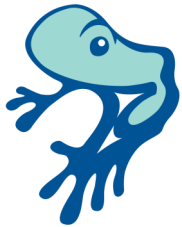
If there is an emergency of student and the parent/guardian or emergency contact is not available, I give permission from SwimKids Studio to obtain emergency medical treatment for any illness or injury that may occur while the student is in class.

For the safety and focus of the student's class, I will NOT tap on the window to get my child's attention or sit in the room to watch without permission of the instructor, other than on parent observation day.

After the class is over, I will be there on time to pick up my child. SwimKids Studio is NOT responsible for my child when they are not attending class.

If the parent/guardian needs to speak with a class instructor, arrangements must be made OUTSIDE of class time so that classes can stay on schedule.
